OPENING AND TIMELINE OF PROCESS

- Final task force meeting for Carrboro Connects (most likely)
- Last few months have been spent preparing the draft plan for the Nov 16th Public Hearing
- Last Task Force meeting asked the Council to hold the hearing and accept public comments
- By April 19th will have a revised draft to Town Council

SUMMARY OF FEEDBACK ON PUBLIC HEARING DRAFT

- 12 boards/commissions have completed review
- Over 82 comments have been received, touching on topics spanning from accessibility (readability and navigability of the document), feasibility, metrics, and much more
- 8 have voted on a recommendation for adoption
- Currently the team is consolidating all of these comments for Council to consider next steps

CONSIDERATION OF DRAFT RECOMMENDATION FOR ADOPTION

Summary of Task Force Discussion:

- How is it determined which comments get incorporated or not?
 - Trish: We have tried to incorporate all comments we receive; where comments are in conflict, we will try to present those
- A lot of comments have not been incorporated yet important to bring those to the
 Council where there are decisions to be made and issues to be flagged
- Task Force wants to see the comments that have been made to assess whether or not the draft reflects these edits
 - o Group feels extra responsibility to this plan and to getting it right
- This meeting is for the Task Force to discuss plan feedback and comments as a group –
 some of the members are not on an advisory board and thus have not had a chance to
 review and discuss yet.
- Important to understand the comments from the rest of the community in order to negotiate the outcome of the plan as one community
- Meetings / the plan need to have an outcome and action -- especially around zoning,
 building, density, affordable housing, reparations. Continue to emphasize these things
- Town Council is the arbiter of the process and their role is to consider all of the comments holistically and make decisions

Task Force Members Report-Back of Advisory Boards' Review:

- Anahid NTA Board
 - Has had questions about zoning because development in their area will occur through Carrboro zoning.
 - Asked for better definition of these areas and this was added to the plan in the previous version
 - We want to be sure that these areas are recognized for what they are. Goal was there
 would be a transition NTA would retain rural feel as the town develops
 - Road safety conditions continues to be a concern
 - Development "pods" need to connect to other areas and help with connectivity

- David M. Appearance Commission:
 - Still believes there is a lack of emphasis/priority on physical appearance of downtown
 - The word "appearance" does not come up in the current draft
- Amy AHAC
 - Need for increased financial resources should be prioritized
- Maggie RPCR Commission
 - Positive feedback, especially regarding the access to green spaces within a short walk
 - Commission appreciated the RPCR portion of the plan
- Economic Sustainability Committee
 - o Jim Porto
 - Change the ratio of the tax base from 70-80% residential to business
 - With limited spaces for commercial development, best option is to focus on smart density
 - Appearance of the town is important to this as well
 - Parking to support businesses
 - David Jessee
 - Increasing density downtown, enhancing connectivity to the downtown
 - Streamline approval process so that entitlements are easier process can make Carrboro unaffordable
 - Soteria
 - Providing masks, hand sanitizer to businesses
 - Community lawn care network
- Planning Board comments
 - Catherine summarized their comments
 - Inclusion/absence of previously suggested input
 - How would final language be determined
 - Land use planning should align with economic strategy
 - Conflict of hist, preservation and affordable housing
 - Removing "consider" items action verbs
 - Implement changes to LUO more quickly
 - Infrastructure/LUO improvements to support affordable housing
 - Affordable housing section: more partners/resources relevant to goals

- Parking and density
- Rezone appropriate areas to support commercial tax base
- Catherine personal comments
 - Process driven vs. political driven
- Wamia
 - Balance the concern over softer language, while also recognizing that many of the issues are complicated and may actually require further consideration
- Jacqueline T.
 - o Want to see more of what could be implemented in the plan first
 - o Will all of the comments from community members also be shared?
- Rachel Gaylord-Miles
 - Highlighting which of the 35 priority projects carry the most weight "force multipliers" for implementation
- Eliazar
 - o Feedback form on the website doesn't translate into Spanish team will fix
